We have reviewed the materials you submitted with your letter dated May 30, 2018, and your email of November 29, 2018, certifying that the marine survivor locating devices (MSLDs), Ocean Signal rescueME MOB1 and ACR AISLink MOB, comply with the applicable requirements of 47 CFR Part 95 and RTCM Standard 11901.1. Based on the information provided in references (a) and (b), we concur with the report's findings of compliance and have no objection to continuing the process for acceptance with the U.S. Federal Communications Commission (FCC), as applicable.

We note the test procedures included for this equipment, per 47 CFR 95.2987 (b)(3), AIS and DSC signal characteristics as an MSLD intended to send a distress message directly to the U.S. Coast Guard or any other search and rescue organization.

This equipment is not subject to U.S. Coast Guard type-approval per Title 46 U.S. Code of Federal Regulations (CFR) subpart 159, nor should it be marketed as having received such type-approval.
